Mom and I visited a grand aunt who grew orchids as her hobby in Bangkok. I was mesmerized by them and said to myself, "one day, I'm gonna have lots of orchids", said Smiley "and now I do... all colors, all kinds."



In the year 2001, we opened our greenhouse in south Clermont Florida under 20,000 sq. ft. greenhouse, nearly 100,000 plants on 5 acres. We live here, and walk to work in our greenhouse everyday. She specializes in Vandaceous, rare species, and hybrid orchids from Thailand and some rare species around the world. She has new varieties shipped from Thailand each year.

I regret having to miss the May meeting and speaker, but it is 'hard being two places at once when you're really nowhere at all' as the old C&W song goes. Linda and Kevin and I stayed

in Shreveport to take the display down and bring everything home.

What a busy month April was, between our show and the members meeting in Shreveport!!! Many thanks to all of you who worked so very hard in so many ways to make our show a really fine one. The displays were lovely, there were a lot of wonderful things for sale by the vendors, the food was wonderful and the set up and take down went really well. It couldn't have happened without all of you pitching in and working so hard over these last months, and especially immediately around the show itself. Thanks again to all of you for a job really well done. And of course kudos to Kevin for taking the AOS Show Trophy.

The meeting in Shreveport went well even though the venue was more than a little difficult to navigate in terms of getting plants and props in and out of the convention center. The GNTOS display not only won the AOS show trophy, but did so on a UNANIMOUS VOTE – something almost unheard of in orchid judging – especially at a national meeting. It also won the ODC Trophy and the trophy for the best society exhibit over 100 feet. The AOS Trophy was also accompanied by a Silver Certificate Award which is fairly unusual, but the second in a row for Kevin's displays. With basically only 4 of us putting in plants we also won about a dozen ribbons each in red, white and blue, and 4 plant trophies and 4 or 5 plants pulled for AOS judging. For something we put together with relatively short planning time, it was incredible, and Kevin did his usual fantastic job while yours truly mainly brought plants and got them ALL entered and labeled. The trophies were really beautiful blown glass orchid statues – will try to bring one to show at some point.

The new AOS website is now up, which is supposed to make things much easier for everyone, and sadly, although I have seen the demos, I have only had time to 'play' with it for about an hour when it first came online, so I can't really extoll it's virtues first hand – will save that for next month. It should be easier to access information and will make it easier to keep track of your membership, and for those who are judges it is supposed to be integrated with the judging materials as well, which will hopefully make our judging task easier.

Hopefully I will be able to make the meeting in June. I am on call that weekend and can only give my best shot at getting all the patients seen in time to be there.


